THE UNDERSIGNED AGREES TO THE FOLLOWING CONDITIONS:

1) NOT TO SERVE ALCOHOL TO PERSONS UNDER THE AGE OF 21 2) NOT TO ALLOW UNDERAGE SMOKING WITHIN THE SHELTER* 3) TO CLEAN UP AREA OR BE HELD FINANCIALLY RESPONSIBLE FOR THE CLEANUP OF ANY DEBRIS RELATED TO THE CONSUMPTION ACTIVITY 4) TO RESTRICT ALCOHOL AND TOBACCO TO THE SHELTER AREA 5) TO ABIDE BY ALL OTHER PARK AND ZELIENOPLE BOROUGH RULES AND REGULATIONS

THE PERMIT FEE IS \$10.00 AND IS TO BE REMITTED BY A SEPARATE CHECK MADE PAYABLE TO THE COMMUNITY PARK ASSOCIATION. FAILURE TO COMPLY WITH THE ABOVE CONDITIONS WILL RESULT IN THE IMMEDIATE REVOCATION OF SAID PERMIT. THE UNDERSIGNED ALSO AGREES, ON BEHALF, OF HIMSELF, HIS HEIRS OR ASSIGNS AND/OR ANY ORGANIZATION HE REPRESENTS, ITS SUCCESSORS, ASSIGNS, MEMBERS, PARTICIPANTS AND ATTENDEES AT ANY FUNCTIONS SUPPORTED BY THIS PERMIT, TO RELEASE, INDEMNIFY AND HOLD HARMLESS THE BOROUGH OF ZELIENOPLE, COMMUNITY PARK ASSOCIATION, INC, OR FRIENDS OF THE PARK, ITS OFFICERS, EMPLOYEES, SUCCESSORS AND ASSIGNS FROM ANY AND ALL CLAIMS, LIABILITIES AND EXPENSES WHATSOEVER, INCLUDING COSTS OF DEFENSE AND ATTORNEYS' FEES, DIRECTLY OR INDIRECTLY ARISING OUT OF OR RELATING TO OR RESULTING FROM ANY PERSONAL INJURY TO ANY PERSON OR PROPERTY DAMAGE TO ANYTHING ARISING FROM APPLICANT'S USE OF THIS PERMIT GRANTED BY THE BOROUGH OF ZELIENOPLE TO ALLOW THE POSSESSION AND CONSUMPTION OF ALCOHOLIC BEVERAGES AND TOBACCO, WITHIN THE RENTAL SHELTER, IN THE ZELIENOPLE PARK.
